As per the last few meetings, there are still a lack of rides currently posted on the runs list. However, when rides are posted the turnout is invariably very good and the numbers arriving at the cafe stop is also very good. It was hoped the Tri-Vets route checking rides would provide an opportunity for some new ride leaders to give it a try, however this didn't really work out and although the turn out on these rides was good, we didn't get any new ride leaders.
As a club we currently have 111 members, of which 39 are registered ride leaders, however this year to date out of 74 led rides we have only had 14 different ride leaders. Many thanks to those who have led a ride, and on a positive note there have been 5 brand new/returning ride leaders this year.
